The solution collects and cleanses data with different format from relevant operational systems and transforms it into social-care intelligence data, like social status, annual income, personal and family possessions, etc. This data is easily accessed by system users through interactive analytical views that assist decision makers in Aid Granting entities to better decide on the nature of aid required for eligible applicants.


