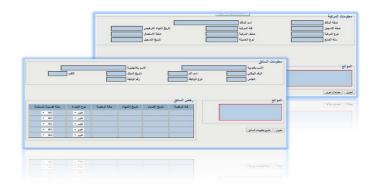


Drivers System
